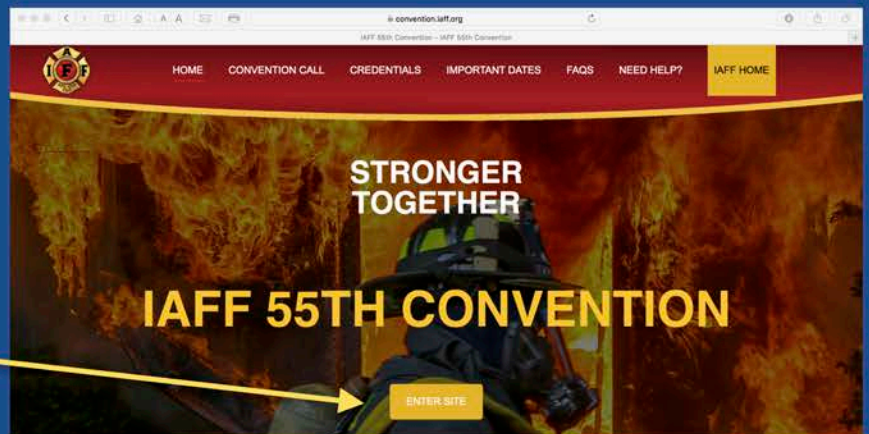
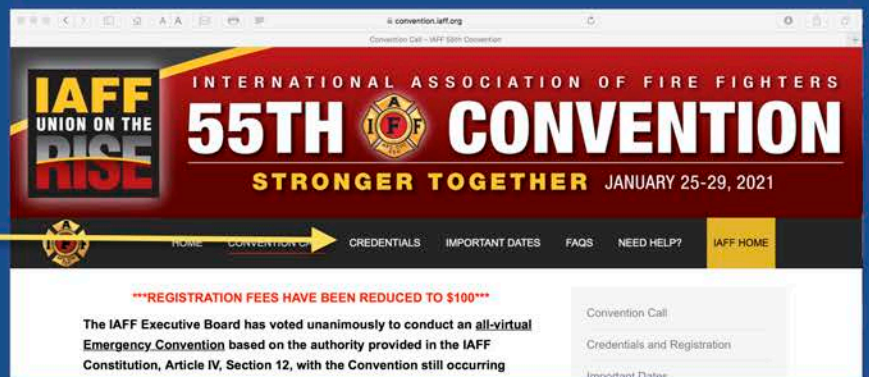

Instructions for Sending Proxy and Alternate Proxy

Only locals of 100 or less can send a proxy to convention.

In order to assign a proxy, the proxy carrier must already be credentialed *and* registered (paid). The proxy carrier is the delegate from the local that will be attending convention.

Instructions for 1st Approving Officer

This process may be initiated by either the affiliate president or secretary/secretary-treasurer.

1. Sign into the Convention Credentials website then click **Step 1**.

Proxies

Assign Proxy / Alternate Proxy

To assign a Proxy/Alternate Proxy, either use the drop down menu to select an individual record and click "Add" or use the magnifying glass to search by First Name, Last Name or Local number and select the individual. Delegates will only appear in the drop down menu if they are in the process. Once you find the record, select the individual and click the "Add" button.

Article IV, Section 2(B) of the IAFF Constitution and By-Laws, as well as the federal Labor-Management Reporting and Disclosure Act, requires that proxy delegates be selected by secret ballot procedures. By selecting and "Adding" an individual as proxy representative for your local, you are confirming that the individual was selected as a proxy for your local in accordance with these procedures.

Select proxy and alternate (if sending) by the drop down menu or the magnifying glass and then assign a Credential Type.
*In order to assign a proxy, the proxy carrier must already be credentialed AND a registered (paid) delegate.
*Proxy and Proxy Alternate must be from the same local.

PLEASE NOTE - COMPLIANCE WITH FEDERAL LAW. Federal Law and the IAFF Constitution and By-Laws require that Delegates (including proxy carriers) to the IAFF Convention be elected in compliance with the federal Labor-Management Reporting and Disclosure Act (LMRDA), a U.S. law that applies to the IAFF and certain other covered labor organizations. In submitting credentials to the IAFF, you will be asked to verify that the election of your affiliate's delegate(s) - other than delegates attending as state/provincial officers but including any local delegate who, by virtue of local office, is a delegate to the IAFF Convention - were elected in accordance with the LMRDA, the IAFF Constitution and Canadian local unions. It does not apply to emeriti, or delegates at large. Please read through the [Convention Call](#) and the [Pre-Convention Call](#) for more information on the requirements of federal law for the election of delegates to the IAFF Convention. If your delegates(s) were not elected in accordance with the LMRDA, the IAFF Constitution and Canadian local unions, you must complete a delegate election in order to send delegates to the Convention. By proceeding with this registration of delegate credentials, you are affirming that your delegates were elected in accordance with U.S. federal law.
